**Sub: Revision in the Annual Fund Limit for regular M&R works for bldgs. (including day to day maintenance) in JNVs from fund disbursed to Principal.**

Consequent upon approval of 35<sup>th</sup> Executive Committee dated 31.08.2017 and in supersession of limits issued vide letter No. 1-2/2001/NVS(GM) dated 06.08.2001 and No. F. 1-4/2004-NVS(GM) dated 11.08.06, the revised fund limits for Maintenance & Repairs works to be done at Vidyalaya level shall be as defined as below w.e.f. 01.09.2017.

1. The funds as per annual financial limit shall be directly disbursed from NVS Hqrs to JNVs.
2. All M&R expenditure under this order shall be clearly recorded in M&R Register in Vidyalaya which shall be available for scrutiny at any time by

- JNV officials visiting Vidyalaya and one copy of the M&R register will be with EE RO at RO office.
3. In no case funds more than maximum financial limit mentioned in Column - [5] shall be issued to Vidyalaya.
  4. Additional funds shall be disbursed to Vidyalaya through Regional Office only after fulfilment of condition therein, as mentioned in Col. [6].
  5. Expenditure done under Additional financial limits shall be finally certified by EE, RO.
  6. The funds issued to JNVs under M&R head herein shall not be utilized for any other purpose than M&R works for buildings/campus.

The M&R works in JNVs by Principal shall be executed as per the guidelines & procedures already *en-force* and modified up-to date time to time.

The expenditure shall be charged to the Head of Accounts-M&R(Plan) for the relevant year.
