## NOTIFICATION

**Sub: Revision in the Annual Fund Limit for Major regular M&R works sanctioned from M&R funds disbursed at RO level - reg.**

Consequent upon approval of 35<sup>th</sup> Executive Committee dated 31.08.2017 and in supersession of limits issued vide letter No. 1-2/2010/GM(Constn)-NVS dated 14.01.2011 and circular no. 1-2/2012/GM(Const.)/NVS/35 dt. 08.02.2012, the revised fund limits for Maintenance & Repairs works to be done at Regional Office level shall be as defined as below w.e.f. 01.09.2017:

1.	Regional Office	100.00	200.00	DC RO shall sanction the estimates for M&R works for buildings upto Rs. 5.00 lacs in each case.

**Notes:**

1. The funds as per above annual financial limit shall be directly disbursed to concerned DC RO from NVS Hqrs.
2. All M&R expenditure under this order shall be clearly recorded in M&R Register in Vidyalaya & Regional Office which shall be available for scrutiny at any time by JNV officials visiting Vidyalaya/RO.
3. In no case funds more than limit defined in Col. 5 shall be sanctioned in each case. However, DC RO shall sanction the estimates in planned manner so that all JNVs within the region shall get funds for proper maintenance and having healthy environment in the JNV campus.
4. The estimates at RO level shall be sanctioned by DC RO with the recommendation of EE, RO. The final expenditure for the works

sanctioned within the funds mentioned above shall be finally certified by EE RO.

5. The funds issued to JNVs under M&R head herein shall not be utilized for any other purpose than M&R works for buildings/campus.

The M&R works sanctioned at DC RO level shall be executed by Principal as per the guidelines & procedures for M&R works already *en-force* and modified up-to date time to time.

The expenditure shall be charged to the Head of Accounts-M&R(Plan) for the relevant year.
