NOTICE

Providing opportunity of transfer to PGTs / TGTs (under 10 years bond), who did not get transfer outside hard Station in round 01 of transfer

It is for information that transfer list uploaded on transfer portal on 09.01.2018 in respect of PGT / TGT under 10 years bond indicates that a total of 86 teachers franchised their preferences for transfer. But 53 eligible teachers have got transfer (list displayed on 09.01.2018) depending upon their preference, eligibility criteria, length of service under bond, provision of priority and availability of vacancy. Rest of them did not get transfer for want of vacancy / rejection due to willingness for transfer within hard station / registering very few preferences while opting online.

Taking into account the length of service rendered by them in hard stations the competent authority has decided to offer one more opportunity to those eligible teachers (under 10 years bond) who did not get transfer outside hard / very hard station despite being eligible. The criteria and steps for providing opportunity of 2nd round of transfer of such PGTs / TGTs will be as under:

6. The teachers who have completed 10 years of service under bond by 31.12.2017 and did not get transfer outside hard station in 1st round of transfer would only be eligible to apply for 2nd round. All 53 teachers who have got transfer would not be eligible to apply in this round in any case.
7. Updated vacancy will be available on the designated transfer portal www.nvsemployeeportal.org.
8. As this transfer drive is meant for transfer of eligible teachers from hard stations to outside hard stations, the application containing preference for transfer within hard stations of Shillong and Chandigarh Region should summarily be rejected at vidyalaya / RO level.
4. Procedure of opting preferences by teachers and approval by the Principal and the Regional Office will remain similar to that of 1st round.
10. Eligible teachers may be requested to opt any number of vacancies so as to have maximum probability of getting transfer outside hard station.

The time schedule of the activity will be as under:

01	Submission of preferences (online) by the teachers to the Principal.	17.01.2018 to 19.01.2018
02	Forwarding of the scanned copy of the application to RO (through mail)	17.01.2018 to 20.01.2018
03	Forwarding of all the compiled applications (soft copy) by the RO to Estt.II, NVS, Head quarters (through mail)	17.01.2018 to 22.01.2018

It will be the sole responsibility of the Principals to keep their eligible teachers aware of applying for the 2nd round of transfer, if the teachers are on leave or on vacation.

Therefore, all concerned (Teachers / Principals / Regional Offices) are, hereby, requested to complete the required formalities within the prescribed time schedule.
