Sub:- Stepping up of pay of PGTs/TGTs who joined NVS prior to 01.01.2006 with reference to direct recruited PGTs/TGTs joined on or after 01.01.2006.

Sir,

It has been observed that some of PGTs/TGTs, who have joined NVS prior to 01.01.2006, are filing their grievances to this office repeatedly to step up their pay with reference to the directly recruited juniors appointed on or after 01.01.2006 in their respective cadre.

Pay of the PGTs who joined NVS prior to 01.01.2006 has been fixed by multiplying their existing basic pay as on 01.01.2006 by the factor of 1.86 rounded off to the nearest multiple of 10 and GP 4800 and those PGTs who have joined NVS on or after 01.01.2006 on direct recruitment basis are granted entry pay as indicated in Section II of Part A Of First Schedule of the CCS (Revised Pay) Rules, 2008 i.e. 13350 + GP 4800 (Rs 18550). By virtue of different methods of fixation of pay for PGTs who joined prior to 01.01.2006 and who joined on or after 01.01.2006, some of senior PGTs working in the cadre prior to 01.01.2006 are drawing less pay as compared to their junior.

Similarly in the case of TGTs/Misc. category teachers who joined NVS prior to 01.01.2006, their pay has been fixed by multiplying the existing basic pay as on 01.01.2006 by the factor of 1.86 rounded off to the nearest multiple of 10 and GP 4600 and they have been drawing less pay as compared to those TGTs/Miscellaneous category teachers who joined NVS on or after 01.01.2006, as they are getting entry pay i.e. 12540+4600 GP.

In view of various pending court cases in different Hon'ble CATs & Hon'ble High Courts on the above issue and in light of Hon'ble Supreme Court of India's order dated 01.09.2017 on the issue, wherein the Hon'ble Court has directed to rectify the anomaly of two pay structures for same TGT / PGT, the issue was reconsidered in the light of Recruitment Rules 2007 for TGT and PGT and it has been decided to permit PGTs and TGTs appointed prior to 01.01.2006 to get their pay step up with reference to directly recruited first PGT and first TGT respectively who was directly recruited on or after 01.01.2006.


Similarly, in case of Music Teacher, Art Teacher, SUPW Teacher, Librarian, PET (Male) and PET (Female), also it has been decided to permit these teachers appointed prior to 01.01.2006 to get their pay step up with reference to directly recruited first teachers in that category on or after 01.01.2006.

A consolidated list of teachers to whom the pay will be revised as per the above direction is to be forwarded to this office in the format given below on or before 31.01.2018 for record purpose.
